



Terms and Conditions

These terms and conditions apply to the Aviva Premiership Rugby 1st Timers prize draw (the "Promotion"). Entry to this promotion is acceptance of these terms and conditions. Therefore, please read these carefully.

The promoter of this Promotion is Premier Rugby Ltd 7th Floor, Regal House, 70 London Road, Twickenham, Middlesex, TW1 3QS (the "**Promoter**").

No purchase is necessary to enter this Promotion.

The Promotion is only open to United Kingdom residents over the age of 18 who complete and submit the entry form featured on www.premiershiprugby.com/avivafirsttimers and who have not previously attended a game at the home club for which you have selected on the entry form for the Promotion. (i.e. your details do not already exist on the club's ticket purchasing database).

The Promotion is not open to anyone **directly** connected with the Promotion.

The prize is one pair of rugby tickets to an Aviva Premiership Rugby match selected from the drop down list on the entry form for the home team and at that team's home club (the name of the team appearing first on each game listed is the home team) (the "**Prize**") Only one entry per person will be accepted and no entries on behalf of another party shall be accepted. Only one match entry will be accepted.

Your details will be passed across to the club for which you have selected tickets and you will be eligible to enter the prize draw if your details do not already exist on the club's ticket purchasing database.

The winners will be selected at random from all eligible entries within each game category featured within the entry form received prior to the Closing Date (the "**Winners**").

There shall be a minimum of 12 Winners per rugby match listed within the drop down list on the entry form.

The closing date will be three weeks prior to each rugby match of the selected game, (the "**Closing Date**"). Entries received after this date will not be processed.

The Winners will be contacted [within 10 working days after the Closing Date], by phone or by email, by the club of which you have selected tickets. If you cannot attend, the club will select another applicant to use the tickets.

The Promoter may ask the Winners to provide proof of age and/or country of residence.

The Winners agree to take part in post-Promotion activity.

The Prize is non-exchangeable, non-transferable, not for resale and is not redeemable for cash or other prizes. The Promoter accepts no responsibility for any costs not associated with the Prize (e.g. travel expenses, merchandise, meals, beverages, transfers or taxis), which are not expressly stated to be included within the Prize.

The Promoter reserves the right to modify or substitute the Prize with a prize of equivalent or higher value in the event of circumstances outside of its control.

Nothing in these terms and conditions shall exclude the liability of the Promoter for death, personal injury, fraud or fraudulent misrepresentation as a result of its negligence.

Subject to the above, the Promoter accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Promotion or accepting the Prize.
