

### **Aberdeen Football Club plc. Summary of Key terms of Membership Scheme – March 2018**

Please note that the below is only a summary of certain key terms and conditions applicable to the membership schemes operated by Aberdeen Football Club plc (the “**Club**”). Capitalised terms used in this summary have the meanings given to them in the Terms and Conditions. This document is provided for information only and the purchase of any Membership will be subject to the Terms and Conditions.

<b>Matter</b>	<b>Key terms to note</b>
Types of Membership	<p>There are four categories of membership as follows:</p> <ul style="list-style-type: none"><li>• International Membership (open to non UK residents. £18/month or £216 per annum)</li><li>• Premium Membership (open to UK residents over the age of 12. £18/month or £216 per annum)</li><li>• Standard Membership (open to UK residents over the age of 12. £12/month or £144 per annum)</li><li>• U12s Membership (open to UK residents under the age of 12. £8/month or £96 per annum)</li></ul>
Term/Renewal	<p>Memberships run for a period of one year from the date on which the Club has confirmed acceptance of the application for the relevant Membership. Memberships will automatically renew annually if the Club has given notice of renewal and the relevant Member has not cancelled the Membership at least 10 working days prior to the renewal date.</p>
Cooling off period	<p>You may cancel your membership within 14 days of the date of purchase, for any reason. Any member cancelling within 14 days of the date of purchase will receive a full refund.</p>
Benefits of membership	<p>The benefits of each Membership Scheme are set out in Schedules 1, 2, 3 and 4 of the Terms and Conditions. [A summary is available at <a href="http://afc.co.uk/aberdna">afc.co.uk/aberdna</a></p>
Suspension or Termination of Memberships	<p>In certain circumstances, as set out in condition 11 of the Terms and Conditions, the Club may terminate or suspend a Member’s participation in any Membership Scheme.</p>

	<p>Where any Member's participation in a Membership Scheme has been terminated or suspended the Club will have a right to recover a sum equal to the proportion of the full retail value of any Membership Benefit fully enjoyed by the relevant member, which is proportionate to the term remaining on the relevant Membership at the time of termination or suspension.</p> <p>By way of example: where a Premium Membership is terminated after six months and the relevant member has obtained a Club replica shirt, the Club will be entitled to recover a sum equal to 50% of the retail price of a Club replica shirt from the relevant Member.</p>
