#### SUMMARY OF ESSENTIAL ELEMENTS OF CITING/REFEREE'S REPORT/FOOTAGE

The Report of the Citing Commissioner, Alberto Recaldini, indicated that the player was cited for an offence contrary to Law 9.12 which, he reported, occurred in the 72<sup>nd</sup> minute on the match, immediately prior to the scoring of a try by the Mr. Rokoduru (Agen 13). The Citing Commissioner reported that Agen 13 was struck between the neck and the chin by the right shoulder of the Player. It was reported that this had resulted in a concussion injury to Agen 13.

The report stated that Agen 13 had remained on the ground and had required medical assistance. The report outlined that Agen 13 had walked from the pitch but did not return to play as, according to the report, "...this was his second concussion in this game and he had to be replaced". The Citing Commission reported that he spoke to the Agen Team Doctor after the match and was told that Agen 13 would, in the following days, be referred to a neurologist for review.

The Referee and Assistant Referees submitted statements advising that they did not see any act of foul play or what had caused the injury to the victim player.

In terms of match footage, there was one camera angle only available to the Committee. The footage begins just one second before the incident the subject of the citing takes place. The footage shows Agen 13 in possession, carrying the ball under his right arm and approaching the opposition try line at speed. The Player is to the right of Agen 13 as Agen 13 approaches the try line. A tackle is made on the victim player by Grenoble 19 which begins at the victim player's waist and moves downwards. This tackle is still in progress when a tackle is also made by the Player on Agen 13. Both players are in upright positions. An attempted tackle is made by the player which fails to halt the progress of Agen 13 who proceeds to score a try. In the process of doing so he is tackled by Grenoble 21, Lilian Saseras. Following the act of scoring Agen 13 remains on the ground. The match footage shows that he is attended to the team medic. Agen 13 remains on the ground for approximately one minute whilst receiving attention. He then gets to his feet and leaves the pitch.

## ESSENTIAL ELEMENTS OF OTHER EVIDENCE (e.g. medical reports)

A statement was received from the Agen Team Doctor, Dr. Martial Lousteau. Dr. Lousteau confirmed that he attended to the Agen 13 on the pitch. He confirmed that Agen 13 was aware and responded well to questions asked of him. Dr. Lousteau reported that as he had already carried out a concussion protocol on that player and "...fearing a trauma" he made the decision to permanently remove the Agen 13 from play as a precaution. A HIA2 was carried out post match which was normal. Agen 13 attended for assessment by a neurologist who reported no injury and passed the victim player fit to play.

Agen 13 submitted a brief statement in which he said "...I have seen the neurologist and everything is Ok, I didn't any pain or anything else during the game. Everything was a usual, I'm perfectly fine"

Mr. McTiernan presented the case on behalf of EPCR. He reminded the Committee that the onus of proof in respect of the citing complaint lay with him. It had been decided prior to hearing, by the Chairperson, that the citing hearings in respect of this player and in respect of his team-mate Lilian Saseras should be heard together and Mr. McTiernan was of the view that, although unusual, it was the appropriate way in which to proceed in these cases. Mr. McTiernan expressed the view that the cases were evidentually challenging and that it had been difficult for the Citing Commissioner to establish which, if either, of the players had been responsible for the apparent injury to the victim player. He submitted that the Citing Commissioner had, correctly in his view, citied both players in order to afford the best possible opportunity to the Committee to consider the incident whilst having both players present.

Mr. McTiernan pointed out to the Committee the main elements of the Citing Commissioner's Report. He asked the Committee to bear in mind that English not the native tongue of the Citing Commissioner and would in fact be his third language. With that in mind, he suggested to the Committee that any reference made by the CC to concussion or to Agen 13 having been concussed should be interpreted as meaning a broad reference to a head injury event.

Mr. McTiernan made reference to the match footage. He submitted that the Player was upright and that the tackle was high. He pointed to the rocking back of Agen 13's head as contact is made. Mr. McTiernan conceded that the video footage was probably not conclusive as to the point of contact but suggested that the footage broadly supported the citing report. It was his submission that the Player crouched, planted his feet and drove upwards into contact. He suggested that the Player was in a fully upright position at the point of contact and that Agen 13's head whips backwards, consistent with a strike to the chin or jaw. Mr. McTiernan argued that the match footage and the medical evidence that was available at the time of the citing were sufficient to prove, on the balance of probabilities that the act on foul play had occurred.

Mr. McTiernan explained that the match was not televised and that the only footage available was that of the home club. This would not have been available to the CC until some time after the match.
SUMMARY OF PLAYER'S EVIDENCE
Written submissions were made on behalf of the player in advance of the hearing and the player also have his own evidence at the hearing. The Player denied that he had committed any act of foul play. The Player explained that he was on the wing, in the defensive line, as Agen 13 approached with the ball. He said that the opposition winger had called for the ball and that his focus was on that player. He was aware of a gap in the defence and realised also that Agen 13 was not going to pass to his winger. The player explained that from his point of view, at that point his only option was to try to stop or block the ball. Agen 13 was tackled low by the Player's team-mate, Agen 19, and so the Player submitted that this only option was to go high to attempt to dispossess Agen 13. The Player made reference to the match footage in support of his explanation. The Player denied that any contact had been made by him with the neck or head of Agen 13. He had tried and failed to block the ball and said that he was beaten by the strength and pace of Agen 13. When asked about where his right arm had made contact with Agen 13, the Player indicated that his right arm had made contact with the ball. The Player suggested that other players "are the first judge when there is something wrong" and pointed out that there had been no reaction to the tackle by any of the Agen players. The Player also made reference to the post match medical evidence and the statement of Agen 13 which confirm that no injury had been sustained.
FINDINGS OF FACT
The Committee found the match footage to be inconclusive and that same did not show any clear contact between the shoulder, or any other part, of the Player and the head of Agen 13. The Committee found the Player's explanation of his actions to be credible. The Committee found therefore that the Player did not commit the act of foul play the subject of the citing report and the citing was therefore dismissed. The parties were advised of the right of each to Appeal.
