EPCRUGBY.COM – CHAMPIONS TRY OF THE ROUND COMPETITION

1. TERMS & CONDITIONS

This document sets out the rules for the Competition. All participants hereby warrant that they have read these Terms and Conditions carefully to validate their entry. Entry into this competition is deemed acceptance of these Terms and Conditions.

2. ORGANISER

The Competition is organised by European Professional Club Rugby (hereinafter referred to as "EPCR"), headquartered at Boulevard de Grancy, 39, 1006 Lausanne, Switzerland.

3. HOW TO ENTER THE PRIZE DRAW

There will be five Heineken Champions Cup tries shortlisted by EPCR for the Try of the Round Competition on www.ePCRugby.com/champions-cup/fanzone/try-of-the-round/. Participants who give their vote for the try that will be eventually selected as the winning try will enter a random draw via computer. The prize winner will then be notified by email using the email address provided to enter the Competition.

The winning try is determined by a combination of the fans' votes and the choice of a rugby expert selected by EPCR for each round. The winning try is announced on the Thursday morning after each round.

If the selected prize winner does not meet the eligibility criteria set out in these rules, a re-draw will be conducted to select an alternative winner.

4. PARTICIPATION PERIOD

The participation period for each Competition will be from the Monday morning at 09.00CET after each Heineken Champions Cup round, until the Wednesday evening at 18.00CET. There will be a combined Competition for the quarter-finals and semi-finals that will be launched on the Monday following the semi-final matches.

5. PRIZES

The prizes that can be won by the participants depend on the round and will be chosen at EPCR discretion among (but not limited to) Gilbert rugby balls, signed jerseys and match tickets.

For the election of the "Try of the Season", the participants will be able to choose among the seven winning tries from previous rounds of Competition, and selected other scores.

Any other expenses incurred by a match ticket prize winner and their guest with regards to travel, meals and in the general use and/or enjoyment of the match tickets, are the sole responsibility of that winner and guest.

No prize can be sold or exchanged for cash. A prize may be passed on to friends or relatives but the winner will remain ultimately responsible to the fullest extent permitted by law for any actions involving the use of the prize by the transferee. EPCR will not be responsible for any inability of a prize winner to take up the specified prize.

6. ELIGIBILITY

The following requirements apply to the Competition:

- (a) All participants in the Competition must be at least eighteen years or older OR, if under 18, be authorised and accompanied by a guardian who is over 18 years of age to claim the match tickets.
- (b) Participation is forbidden to employees of EPCR, companies associated with the organisation of the Competition, their representatives and agents and to any person involved in the implementation and management of the Competition.
- (c) There is no participation fee required to enter or win.

Participants not complying with these terms are subject to exclusion.

7. LIABILITY

To the extent permitted by law, EPCR is not liable for any loss, damage, injury of disappointment suffered in connection with the Competition or claim of any Prize, or any delays or failure (in whole or in part) to perform any of its obligations if such delay or failure is caused by something beyond its control. EPCR will not be held responsible for the winner and/or companion not taking advantage of the Prizes due to health or any other reason.

To the fullest extent permitted by law, participants release and agree to hold harmless EPCR and its respective affiliates, partners, agencies as well as the employees, directors, shareholders, representatives) from any and all liability and/or loss to person and property, resulting from participation in the Competition or acceptance, possession, receipt and/or use/misuse of any Prize (including any travel or activity related thereto).

8. GENERAL

- (a) EPCR reserves the right to terminate, amend or extend this Competition at any time without notice.
- (b) EPCR reserves the right to disqualify entries from anyone tampering with EPCR website or entry process
