Member federations in their first three years of membership shall pay no subscription.</u></li> <li><u>2. The amount of the subscription payable by each member federation shall be determined by reference to its level of participation in major events during the previous four year Olympic period in a formula proposed by the Council.</u></li> <li><u>3.
