

1. Eligibility: Giveaway (the “Giveaway”) is open only to those who donated a minimum of 10 CHF (Swiss Francs) between the launch of the project on 18 June 2015 and 11:59PM CET on 6 September 2016 and who are 18 years of age as of the date of entry. The Giveaway is subject to all applicable federal, state and local laws and regulations of Switzerland.

2. Agreement to rules (“Rules”): By participating, you agree to be fully and unconditionally bound by the Rules contained in this document, referred to as “Rules” and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of FISA, the World Rowing Federation (“FISA”), as final and binding.

3. Giveaway Period: Donations to be entered will be accepted online starting on 18 June 2015 and ending on 6 September 2015. To be eligible for the Giveaway, the online donation must have been received by 6 September 2015 at 11:59PM CET.

4. How to Enter: The Giveaway can only be entered by making a donation of 10 CHF or more using either our online system (<http://www.worldrowing.com/environment/kafue-river-rowing-centre/give>), or by donating 10 CHF or more at a sanctioned World Rowing event. To be eligible to win a prize (“Prize”) the entry must comply fully with these Rules. Entries that are not complete or are completed incorrectly, or do not adhere to the Rules may be refused at the sole discretion of FISA. Multiple donations from the same individual will be considered as one entry. Donating multiple times will therefore not increase your chances of winning. You may not enter more times, by donating from multiple email addresses, identities or devices in an attempt to circumvent the Rules. If you use fraudulent methods or otherwise attempt to circumvent the Rules your submission may be removed from eligibility at the sole discretion of FISA.

5. Prizes: There will only be two winners “Winner(s)” in 1st Prize and 2nd Prize format, as follows:

- 1st Prize: Two round trip economy fare air tickets, booked by FISA or a travel agent appointed by FISA, to Rio, a twin or double (subject to availability) hotel room in Copacabana and two grandstand tickets valid for all eight days of rowing at the 2016 Olympic Games
- 2nd Prize: two grandstand tickets valid for all eight days of rowing competitions at the 2016 Olympic Games

Actual/appraised value of the Prizes may differ at time of their award. The specifics of the Prizes shall be solely determined by FISA. No cash or other Prize substitution is permitted except at

FISA's sole discretion. The Prizes are non-transferable. Any and all Prize-related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the Winner. No substitution of the Prize(s) or transfer/assignment of Prize(s) to others or request for the cash equivalent by the Winners is permitted. Acceptance of the Prize constitutes permission for FISA to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winners selection and notification: Winners of the Giveaway will be selected in a random drawing under the supervision of FISA. Winners will be notified via email to the email address which they submitted on entering the Giveaway, within five (5) business days following the Winners' selection. FISA shall have no liability for a Winner's failure to receive notices due to Winners' spam, junk e-mail or other security settings or for Winners' provision of incorrect or otherwise non-functioning contact information. If the selected Winner(s) cannot be contacted, is/are ineligible, fails to claim the prize within 15 days from the time the award notification was sent, or fails to timely return a completed and executed declaration and releases as required, the Prize may be forfeited and an alternate winner selected.

The receipt by Winner of the Prize offered in this Giveaway is conditioned upon compliance with any and all federal and state laws and regulations.
