Rules of Conduct for Elections

1. Scope of application

These Rules of Conduct apply to individuals and their National Rowing Federations (NFs), as well as any person or organisation acting on their behalf. These Rules are applicable as soon as a member NF informs FISA of its wish to nominate a candidate for the FISA Council.

2. Principles

The conduct of the individual candidates shall comply strictly with the provisions of this document, the FISA Statutes and the FISA Code of Ethics. Candidates and NFs should make no negative comment about a rival candidate(s). The NF of the candidate is responsible for the activities and conduct of the candidate.

3. Printed Materials

Candidates are invited to create an information sheet of a maximum of two A4 size pages (front and back on one piece of paper). In the text, the following points should be addressed: First and Last name, Gender, Year of Birth, Age, Nationality, Education History, Professional History, Sport History.

4. Internet

Candidates may create their own Internet site for informative purposes only.

5. Promotion

Throughout the pre-election period, the promotion of a candidate shall take place with dignity and moderation. The candidate and its NF are entirely responsible for all forms of promotion.

6. Promotion among FISA's member National Rowing Federations

Candidates may promote their candidacy among the member NFs either at the international events to which they have been invited or at international competitions, or by means of sending written documents. The President of the NF will have the opportunity to present their candidate to Congress.

7. Gifts

No gifts or any advantage whatsoever may be given to or received by FISA Council or Commission members, FISA staff and consultants or representatives of FISA member NFs. No promise of any kind of advantage may be made including the offer of development assistance or, for example, airplane tickets to any FISA event. This prohibition shall be respected by the candidates and their NFs as well as by all those acting on behalf of or supporting the candidate.

The Executive Committee may impose penalties, including disqualification, on any candidate who does not comply with this code of conduct.
