1. Documents for the 2020 FISA Ordinary Congress

Member Federations are reminded that the 2020 FISA Ordinary Congress will be held on Friday, 16 October 2020 from 12:00 to 14:00 hrs CEST with registration from 11:30 hrs CEST. This Congress will be held using video-conferencing and online voting technology.

2. Documents for the 2020 FISA Extraordinary Congress

Notice is repeated that the 2020 FISA Extraordinary Congress will be held on Saturday, 17 and Sunday, 18 October 2020 from 12:00 to 15:00 hrs CEST with registration from 11:30 hrs CEST. This congress will be held using video-conferencing and online voting technology.

- a. **Member Federation Proposals** – A proposal for a change to the Advertising Bye-Laws was received from the Swedish Rowing Federation by the **16 July 2020** deadline and will be considered by the FISA Council at its meeting on 10 October 2020. - b. **Proposals for Changes to Statutes and Rules** – After a three-year process involving the Member Federations at MF Conferences, the FISA Council presents the proposed changes to the Statutes and Rules in order to place FISA in alignment with current norms related to good governance, transparency and the IOC's Agenda 2020.
 - Final Proposed Changes to the FISA Statutes and Bye-Laws
 - Provisional Proposed Changes to the Appendices related to the FISA Statutes "as at 15 August 2020"
 - Final Proposed Changes to the FISA Rules of Racing and Bye-Laws
 - Proposed Changes to the Appendices related to the Rules of Racing and Event Regulations "as at 15 August 2020"

As the Appendices to the Statutes and Rules are considered to be Bye-Laws, and as the COVID-19 pandemic has delayed final preparations, the final versions of these appendices, with any further changes highlighted, will be published on 16 September 2020, one month prior to the Congresses.

Please note: The information submitted in the Congress Attendance Forms will be used to provide access to the online meeting and voting platform, as applicable, to registered delegates and observers. Please ensure the information submitted to FISA is accurate.

d. Virtual Meeting Technology and Test Sessions for registered delegates

FISA plans to use the following technology:

- “Zoom” video-conferencing, with simultaneous interpretation (French/English)
- “Lumi” online voting and meeting platform, accessible via a standard web browser

Test sessions will be held during the two weeks prior to the Congresses. The exact dates will be communicated to the delegates that have registered.

4. 2020 Extraordinary Congress MF Consultation Videos and Meetings on the proposed changes to the Statutes and Rules

A programme of information and consultation sessions will be held for member federations, to explain and discuss the proposed changes to the Statutes and Rules and provide an opportunity for MFs to raise questions to FISA. The sessions will be in English only.

3 September – Statutes Questions and Answers published

4 September – 09:00hrs and 17:00hrs CEST, MF consultation meeting, using “Zoom” video-conferencing technology. (MFs will be asked to sign up for one of these two video-conference meetings, based on their time zone)

b. Rules of Racing

11 September - Rules Part 1, presentation and video published

18 September – Rules Part 2, presentation and video published

22 September – MFs to submit comments and questions to FISA

24 September – Rules Q&A published

Friday 25 September – 09:00hrs & 17:00hrs CEST, MF consultation meeting, using “Zoom” video-conferencing technology. (MFs will be asked to sign up for one of these two video-conference meetings, based on their time zone)

c. Registration of Consultation Meeting Delegates

It is strongly recommended that those delegates attending the Consultation Meetings are the same delegates who will attend, and vote, at the Congresses.

5. Delegate Responsibilities for the Virtual Congresses & Meetings

Delegates should be aware that they have the following responsibilities with respect to their attendance at the 2020 Congresses and Consultation Meetings:

- To have a stable and strong internet connection
- To use a computer with Chrome web browser (do not use smartphones & tablets)
- To have mic, camera and speakers (if not already built into your computer)
- To be able to access “Zoom” video-conferencing software
- To watch the presentations explaining the changes to the Statutes, Rules, related Bye-Laws and Regulations (published on the World Rowing website on the dates listed above)
- To attend the consultation sessions and understand the proposed changes to the Statutes, Rules, related Bye-Laws and Regulations

- To discuss the proposals with their Board in advance of the Congress voting sessions
- To attend a test session during the two weeks prior to the Congresses
- To ask questions if there is anything that is not clear, with respect to the Congresses. Please email 2020congresses@fisa.org or raise your questions during one of the Consultation Meetings.
