# Sanctions

A member of the Jury may impose the following sanctions for a breach of the Rules of Racing

- Reprimand
- Yellow Card
- Relegation
- Red Card
- Disqualification

# Sanctions

## Reprimand

- A formal admonishment of a crew when the crew's violation of the rules does not warrant a higher level of sanction

## Yellow Card

- A formal warning for a violation of the rules
- Applies to the next race the crew competes in and lapses when the race is complete
- A Yellow Card still applies if there is a Re-Row or postponement of the race
- A crew awarded two Yellow Cards for the same race shall be awarded a Red Card

# Sanctions

## Relegation (REL)

- Places the crews in last position in a race where the Rules allow (e.g. BUW, Identification violation)

## Red Card or Exclusion (EXC)

- For serious and/or repeated breach of the Rules
- A crew is excluded from all rounds of the event

## Disqualification (DSQ)

- A sanction for the most serious breaches of the Rules
- Disqualifies a rower or crew from all events in the regatta
- A Disqualified rower may not be replaced by a substitute rower
- No member of a Disqualified crew may compete in another event at the regatta.

## Sanction on a Member Federation

- The President of the Jury may provide a report to the Executive Committee on the breach of the Rules
- If the Executive Committee (EC) feels that the sanction that was imposed is insufficient, the EC may:
  - Give notice to the relevant Federation of the breach and additional sanctions that may be considered
  - Invite the Federation to provide a written submission on the issue
  - After considering the report and any submission by the Federation – Apply additional sanctions that the EC considers appropriate

# Sanctions

## Yellow and Red Cards

- A Jury member should notify the crew of the sanction immediately or as soon as possible
- Where a sanction applies to a future race, the President of the Jury must report the sanction in writing to the team manager
- If the crew is not yet on the water, the Control Commission should inform the crew of the sanction when they launch
- The Starter will announce all Yellow Cards that apply to a race before giving the starting commands
- A crew awarded a Red Card at the start will not participate in the race once it has been informed of the Red Card

# 4 legal 'steps'

**OBJECTION** (CREW->UMPIRE/JURY MEMBER)

**PROTEST** (TM->JURY PRESIDENT)

**APPEAL** (TM-> World Rowing EXEC.COMM.)

**COURT of ARBITRATION for SPORT**  
(NF->CAS)

# Objection (Crew)

What to do?

- Raising arm
- Verbally



When?

- At the Control Commission
- At the start
- During race
- After finish

To Whom?

CC Jury Member  
Starter  
Umpire  
Umpire

# Objection (Crew)

To clarify when a crew can object

# Objection (Umpire)

What to do?

- Listen to crew
- Acknowledge receipt of Objection
- Action on Objection

To whom?

- Crews concerned
- Other race officials

When?

- Action immediately
- Decision depends on situation



# Objection (Umpire) (2)

For the Umpire  
How?

➤ By showing a flag

Which flag?



You reject the Objection  
You confirm the result



You accept the Objection or  
you need to make an inquiry  
No result can be released

# Objection (Umpire) (3)

What does the red flag mean?

- Do not release the result
- The Umpire wants to collect extra information



What does the red flag **not** mean?

- The objecting crew has right
- The Umpire must consequently exclude a crew

The Umpire may take all time needed to make a final decision!

# Protest

## (Team Manager)

### Who?

- A crew whose Objection was rejected
- A crew whose ranking was affected by an acceptance of an Objection
- A Crew ruled DNS, DNF, EXC or DSQ

### What to do?

- Written protest
- Deposit of 100 Euro

### To whom?

- President of the Jury

### When?

- Not later than 1 hour after the umpires decision

# Protest

## (Board of the Jury) (1)

Composition (Rowing World Cup or World Rowing Championships)

*3 persons: the President of the Jury and two Jury members, designated by the President of the Jury on a daily (or session) basis prior to the start of racing; ideally they have no other duties during that day (or session).*

Information to teams

*The names of the Board of the Jury shall be displayed on the notice boards in the boathouse area each day.*

Remark:

*During international regattas the President will also nominate 3 substitutes (no-one directly involved in the dispute shall constitute part of the Board).*

# Protest

## (Board of the Jury) (2)

### Task

- The Board of the Jury shall decide if the Protest was justified

### How?

- Collecting all relevant information
- Interview of all parties concerned

### When?

- Before next round of the event
- No later than two hours after the last race of the day

### Remark:

No victory ceremony when a protest is discussed by Board of the Jury

# Appeal

## (Team Manager)

### Who?

- A crew whose ranking was affected by a decision of the Board of the Jury
- A Crew whose Protest against the published results was rejected by the Board of the Jury
- A decision by the Board of the Jury confirmed the decision of a member of the Jury is final and can not be protested

### What to do?

- Written document
- Caution of 200 Euros

### To whom?

- World Rowing Executive Committee

### When?

- The same day the decision of the Board is communicated

# Appeal

(World Rowing Executive Committee)

## Task

- The Executive Committee shall decide if the Appeal was justified.

## How?

- Collecting all relevant information
- Interview of all parties concerned

## When?

- Before next round of the event

## Status

- The decision of the Executive Committee is final within World Rowing's jurisdiction

# Appeal to C.A.S. (National Federation)

Any party sanctioned by a judicial body of World Rowing may appeal the decision to CAS (Fr. TAS) (or Court of Arbitration for Sport) in Lausanne only.

What to do?

- The appeal brief shall set out the facts and reasons on which it is based.

When?

- Within 21 days following receipt by the party of the decision in question.

# Appeal to C.A.S. (C.A.S.)

How?

- The CAS conducts the appeal and rules on it in accordance with its own regulations.

Decision

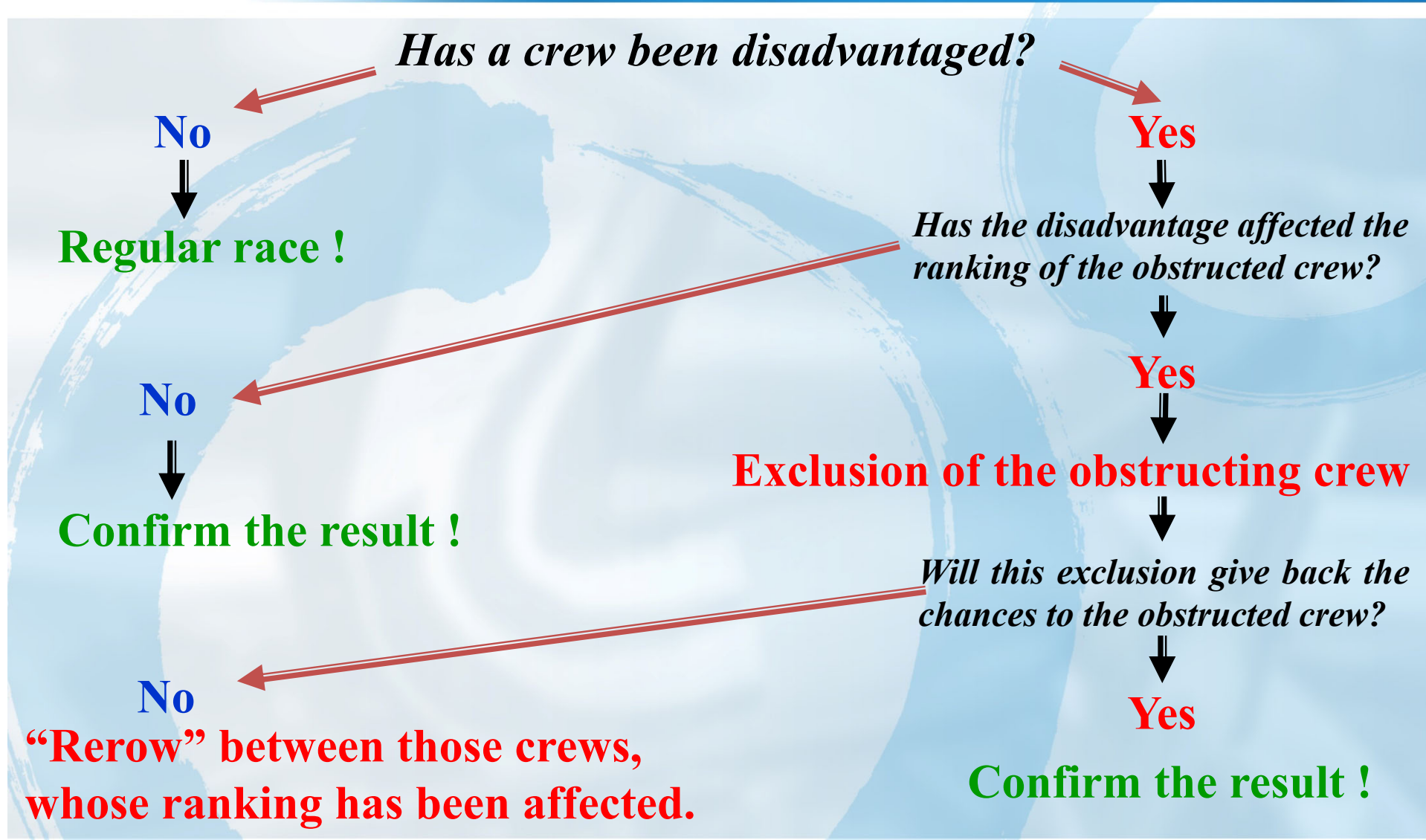
- The decisions made by the CAS are final and may not be appealed.

# General remark

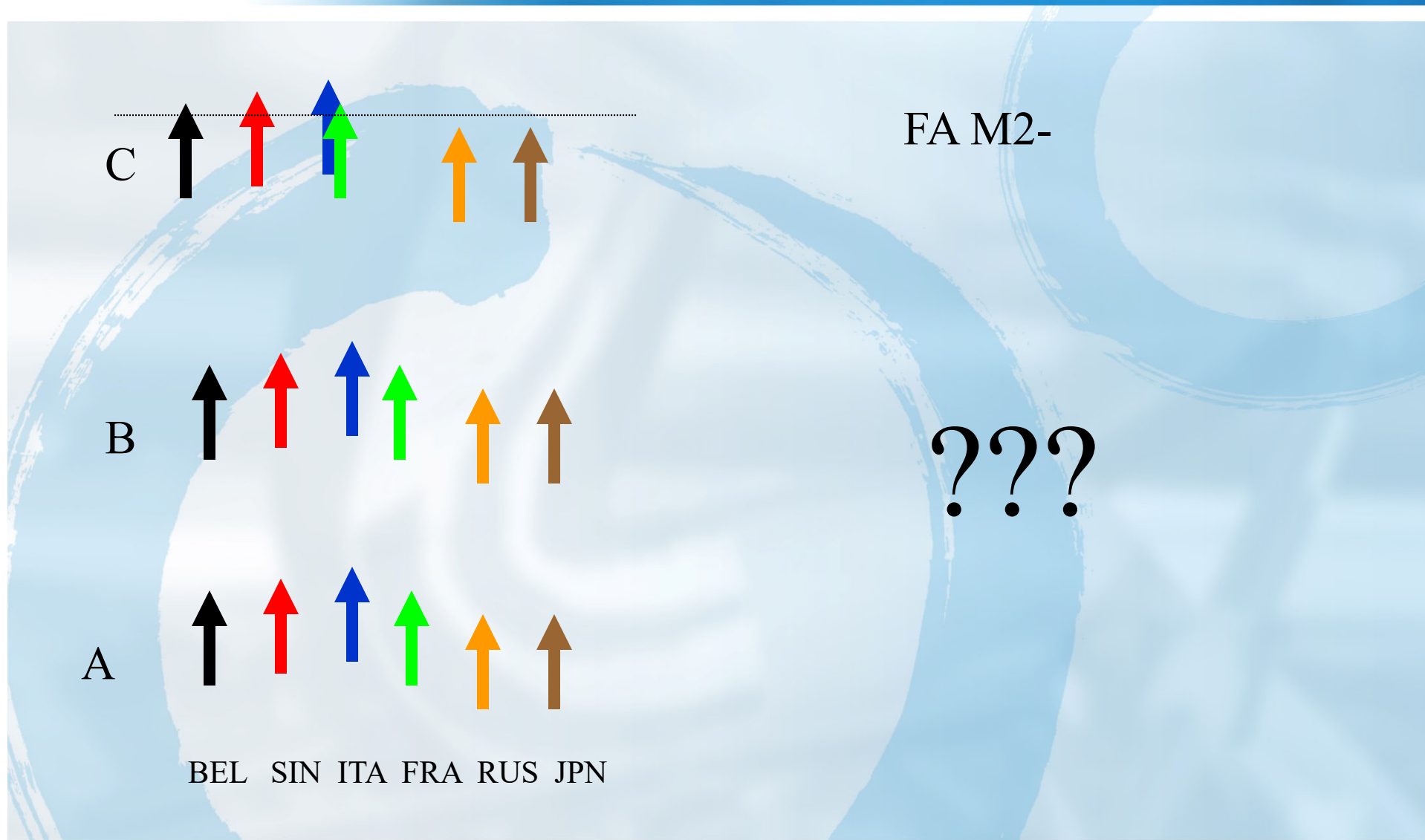
The lodging of a protest or of an appeal shall not have the effect of suspending the decision at stake or any penalty imposed.

However, the protester or appellant may submit a request for suspension of the decision or penalty and the body hearing the appeal or the protest shall rule on the request.

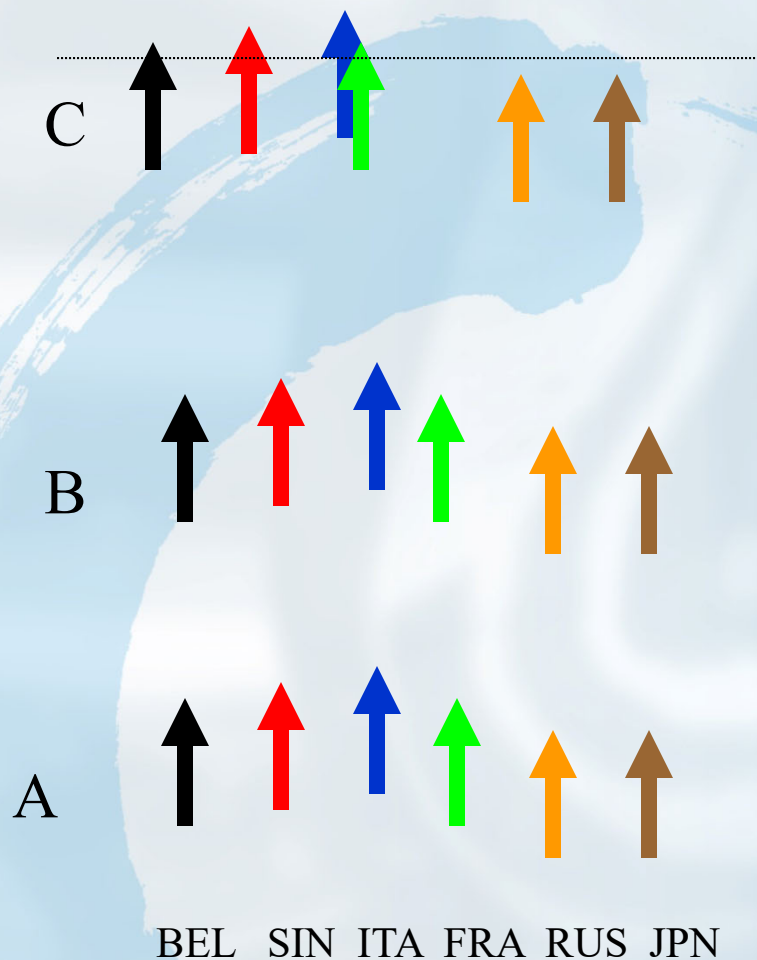

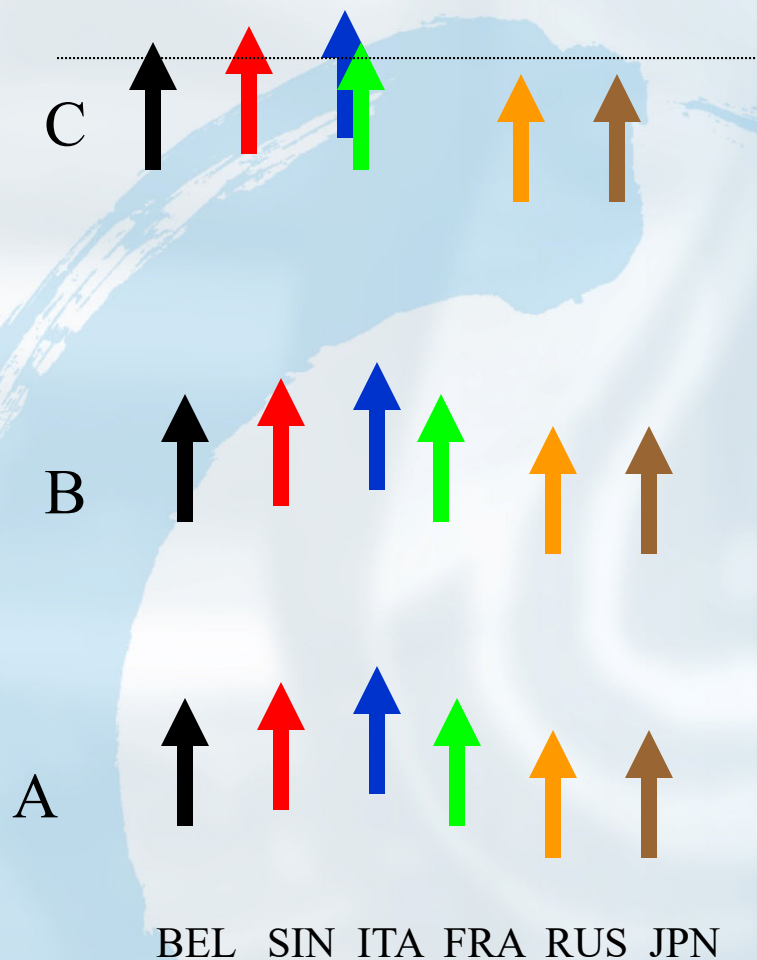

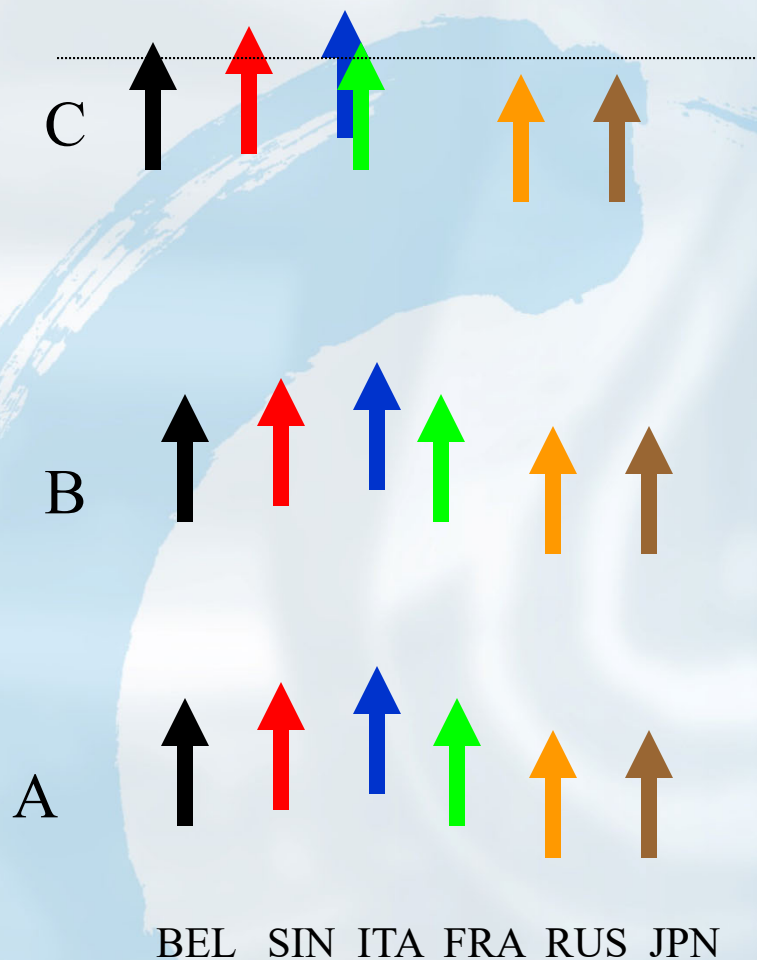

FRA EXC / confirm the result

# Another example (1)

JM4X SemiC/D

Clash between HUN and CRO in last 50 meter ...

All crews within 1 boat length

HUN excluded by umpire

Finish order:

|    |     |
|----|-----|
| 1. | BLR |
| 2. | USA |
| 3. | GRE |
| 4. | CHN |
| 5. | CRO |
| 6. | HUN |

## Another example (2)

|               |    |     |                               |
|---------------|----|-----|-------------------------------|

|               | 2. | USA | In principle qualified for FC |
|               | 3. | GRE |                               |
| <hr/>         |    |     |                               |

|               | 6. | HUN |                               |

REROW between ???

## Another example (3)

|               |    |                |    |
|---------------|----|----------------|----|
| Finish order: | 1. | BLR            |    |
|               | 2. | USA            | FC |
|               | 3. | GRE            |    |
|               | 4. | CHN            |    |
|               | 5. | CRO            | FD |
|               | 6. | <del>HUN</del> |    |

- Only CRO & HUN were affected by clash
- In any case CHN would always been at least 4th
- If CRO would have 1st, 2nd or 3rd, BLR and USA would have been qualified for FC
- REROW between GRE and CRO !

Remark: Protest of GRE was rejected !

Final result: CRO won rerow and was 1st in FC – GRE last in FD
