



## Nominations for 2023 World Rowing Event Juries

Member Federations are now invited to nominate umpires to serve on the juries for the 2023 World Rowing events.

A maximum of 2 nominations per Member Federation, per Event are accepted, provided that the nominated umpires are different genders.

To be eligible for a 2023 Jury, Umpires must have attended a Rules Updating Clinic or Seminar after January 1, 2021.

Member Federations should ensure that any umpire nominated is able to attend the event concerned. World Rowing provides a small travel subsidy for all the mentioned events with the exception of local Jury members at World Rowing Cup regattas.

The deadline for submission of nominations with complete contact information for the nominated umpire (including email address) is **11 november 2022 (midnight CET)**.
