



Nominations for 2023 World Rowing Coastal & Beach Sprint Championships Jury

National Federations are now invited to nominate umpires to serve on the jury for the 2023 World Rowing Coastal & Beach Sprint Championships in **Barletta – Italy** (September 28 – October 8, 2023).

A maximum of 2 nominations per National Federation are accepted, provided that the nominated umpires are different genders.

To be eligible for a 2023 Jury, Umpires must have attended a Rules Updating Clinic or Seminar after January 1, 2021.

National Federations should ensure that any umpire nominated is definitely able to attend the event concerned. World Rowing provides a small travel subsidy.

The deadline for submission of nominations with complete contact information for the nominated umpire (including e-mail address) is **15 March 2023 (midnight CET)**.
